JEWISH HOLIDAYS

Rosh Hashonah begins at sundown Wednesday, October 4, and continues through Sundown Friday, October 6. Yom Kippur begins at sundown Friday, October 13 and continues through sundown Saturday, October 14. Faculty are asked to make appropriate arrangements for Jewish students missing academic work for these high holy days. Any employee who can be spared may be excused for these religious holidays.

REGISTRATION PROCEDURE

Faculty is reminded that the packets of Course Admission permits must be turned in to the Registrar's Office by October 6. To avoid massive confusion at final grade time, these cards should reflect accurately the enrollment in your sections. Proper handling of these packets is essential to ensure accurate records.

WITHDRAWAL PROCEDURE

Students may receive WP (withdrawn passing) grades with the approval of their instructor and advisor. The deadline for a WP grade, which is not entered into the cumulative average, is October 26. After this date, if a student withdraws from a course, he receives a WF, and 0.0 is entered into his cumulative average.
