Chancellor Broderick's address to the faculty is being distributed to all faculty members.

Among the highlights were the timetable for governance in Colleges I and II and for university governance, the need for clear knowledge on the standards required for appointment, retention, promotion, and tenure of faculty, the obligations to justice in hiring faculty from minority groups, and impressing on the faculty that "students have first claim on our time."

Dean of Faculties Dorothy Marshall, in sensing an "unusual quality of vitality in the U-Mass- Boston faculty", added that the role of the academic administrator is "to preserve and protect the process of learning and teaching."

Co-Chairman of the University Senate Donald Babcock reviewed the accomplishments of the Senate during the past year, and outlined many university problems which will be brought to the attention of the Senate during the year.

Prof. Nevin Weaver was elected by the faculty as their representative to the Board of Trustees of the university.

Assoc. Prof. Edward S. Ginsberg (Physics) was elected Secretary of the Faculty.

Among the immediate reactions to the proposal by Chancellor Broderick in establishing a non-profit, tax-exempt community development corporation, separate from the Dorchester, South Boston and Columbia Point communities and from the university, yet including all of them, were editorials in the Boston Globe and by WEEI.

"This was a forward looking speech of a good neighbor..." said the Globe editorial titled "A New Look at Town and Gown."

The WEEI editorialist said the CBS station "thinks other urban universities can take a cue from such a joint effort."

The impact of UMass-Boston on Greater Boston communities is growing. Another example is through the Institute of Learning and Teaching and its cooperation with the Boston School Department at the Lee and Marshall schools in Dorchester.

The Institute's Victor Atkins is working with the Department's staff development program in establishing "open space" programs in the two schools. The goal of the Title II ESEA project is personalized learning for the children and bringing teachers close enoughto the child to identify educational as well as emotional problems that may develop.

A thoughtful Report On the Status of

with each succeeding year more difficult to correct. We feel that the first steps in prevening such a situation are to examine the facts regarding the present status of women at the University and to make these facts available to to both the faculty and the administration."

UMass-Boston and the Joint Center for Urban Studies of M.I.T. have entered into an agreement to establish the Survey Research Program at UMass-Boston. The program will be a service facility for research clients, offering a variety of survey-related services and technical advise including sampling design, interviewing methods, and questionnaire content.

Floyd J. Fowler, Jr., will direct the program, operating out of 20 Boylston st.

The Survey Research Program focuses on data collection for planning and policy decisions. Its services are available to departments and faculty at cost. One of its prime goals is to be of service to the faculty.

Topics covered in previous research surveys include studies on crime, the quality of city services, housing, and public recreation facilities.

Nina Alonso, English, will read from her poetry at the New England Book Festival, sponsored by the Boston Globe at the John B. Hynes Civic Auditorium, Saturday, October 2, at 5 p.m.

The Festival begins on Friday and will run for three days. Prof. Alonso is one of several local poets who will appear at the Poetrython, one of the features of the program.

Louis Lyons, Trustee-emeritus of the University of Massachusetts, is one of the Festival speakers. He will talk about his book "Newspaper Story: 100 Years of the Boston Globe."
