- Generate reports and other documents to be used by the Department of Elder Services, other town offices, organizations that provide services, advocates, and community members

Approaches

Key indicators for becoming a 'livable' community for older adults:


- Demographic information, including population growth
- Availability and affordability of housing suitable for aging in place
- Transportation options that allow individuals to maintain social relationships, access community amenities and needed services
- Availability of community features and services that meet people's evolving needs, including senior center services
- Social support and well-being of adults 45+, including caregiving responsibilities

Methods

- Demographic profile
- Sample Survey
 - Boomers (45+)
 - Seniors (65+)
 - Oldest Old (80+)
- Focus groups
 - Seniors
 - Providers
- Key Informant Interviews with town leaders
- Peer Community Comparison

Example Finding

- One key finding from the Hingham Sample Survey was regarding caregiving duties
- The figure below illustrates that of the 18% of Boomers and 14% of Seniors who carrying out their caregiving tasks
