#### **Jennifer Alford-Teaster, MA, MPH**

Gender Research Institute at Dartmouth (GRID), Bradford, New Hampshire

New Hampshire Women's Initiative (NHWI) board member and Gender Ambassadors Panel (GAP) Co-chair, Jennifer Alford-Teaster, MA, MPH was accepted into the inaugural class of the Gender Research Institute at Dartmouth (GRID) Fellowship program in 2013. The GRID Fellowship lecture series: "Seeds of Change: Gender, Scholarship, and Social Justice" brought to the Dartmouth campus some of the most well-known social activists from around the world. As a GRID fellow, Jennifer represented the voices of New Hampshire citizens that emerged from the contributions of NHWI listening sessions. The summary of the experience resulted in a collaborative paper released in September 2014 called "Understanding Equal Pay in New Hampshire: A review of numbers, citizen voices, and ideas for dialogue".



#### **Jill E. Ashton**

Jill Ashton is the director of the Massachusetts Commission on the Status of Women, an independent state agency that is tasked with reporting on the status of women in the Commonwealth and making recommendations regarding policy that would facilitate their advancement and increase access to equality. She represents the Commission as a member of the National Association of Commissions for Women, where she serves as co-chair of the policy committee. Outside of commission work, Ashton joined the board of Mass NOW in 2006 and is currently serving as president of the state organization. She is a graduate of the Program for Women in Politics and Public Policy at UMass Boston and received her undergraduate degree from William Smith College. She serves on the board of the Center for Women in Politics and Public Policy and is a member of the member of the WAGE Project's Start \$mart Leaders Circle.



#### **Catherine Bailey, J.D.**

Catherine Bailey, JD, is the Legal and Public Policy Director at the Connecticut Women's Education and Legal Fund (CWEALF) in Hartford, a statewide nonprofit organization that seeks to empower women and girls to achieve opportunities in their personal and professional lives. Her work includes overseeing the Legal Education Program, which addresses the civil legal justice gap by providing women and low-income individuals with access to legal information, advocacy, and resources. She also spearheads CWEALF's policy agenda, which includes leading the Campaign for Paid Family Leave, the Family Law Working Group, and participating in the Campaign for a Working Connecticut and the Coalition for Choice. After earning a B.A. from Boston College and a J.D. from Suffolk University Law School, Catherine held several positions in Massachusetts state government, including Assistant General Counsel to the Executive Office of Public Safety and Security, Deputy Chief Legal Counsel to the Massachusetts

State Police, and most recently as Deputy Legal Counsel to Governor Deval Patrick. Catherine is a founding Board member of Autism Families CONNECTicut, a nonprofit organization that provides recreational programs to children and teens with autism, and their families. She also serves on the Board of Directors for Greater Hartford Legal Aid and as a member of the Connecticut Bar Association's Pro Bono Committee and Women in the Law Section.

Elizabeth Barajas-Román, CEO, the Women's Fund of Western Massachusetts. Elizabeth has been a leader in progressive movements including advocating at the national level for the health and rights of immigrant women and their families. Most recently she was a manager at The Pew Charitable Trusts where she directed a portfolio of partners that campaigned for state and federal policy change to improve government performance on issues that impacted children's health. Elizabeth brings a background in impactful philanthropy, data-driven strategy design, fundraising through philanthropic partnerships, and creating coalitions and mobilizing partners. Previously, as the Director of Policy at the National Latina Institute for Reproductive Health (NLIRH), Elizabeth directed the organization's Washington, D.C.-based office where she was instrumental in expanding the visibility of NLIRH on the national stage. Elizabeth is frequently invited to be a voice in national policy discussions in the media, at the White House, on Capitol Hill and in target states. In addition, Elizabeth's leadership has been recognized by several national fellowships including the Center for Progressive Leadership Executive Fellowship, the Rockwood Leadership Institute, and an appointment to the American

Public Health Association Committee on Women's Rights. She is a certified Project Management Professional (PMP), a graduate of Oberlin College, and received her master's degree in international policy from Harvard University.

Ann Bookman, a nationally known researcher and policy expert on women's issues, work-family balance and community engagement, is Director of the Center for Women in Politics and Public Policy at University of Massachusetts Boston. She has directed several university-based research centers, including the MIT Workplace Center at the Sloan School of Management. Bookman was a Presidential Appointee in the first term of the Clinton administration and served as Policy and Research Director of the Women's Bureau at the U.S. Department of Labor. She was also Executive Director of a bipartisan Commission that studied the impact of the FMLA on workers and employers. She was principal author of the commission's report to Congress, "A Workable Balance." She lives in Boston and is a Board member of several community-based organizations in the city, including Nurtury, an innovative early care and education agency serving low-income children and their families in a number of Boston neighborhoods.

Rep. Sarah Buxton serves on Vermont's House Education Committee and lead the effort to establish universal access to publicly funded prekindergarten education in Vermont during the 2013-2014 legislative session. She graduated from Vermont Law School in 2010 and immediately launched her campaign for the Vermont House. She defeated the incumbent candidate by one vote, winning subsequent elections to continue her work on improving early childhood investments, and increasing access to employment, equal pay, and affordable education. Sarah was recently named "Legislator of the Year" by the top business trade association in Vermont for her work on pre-k and workforce development. She has served as a trustee on numerous boards - including the University of Vermont, Building a Local Economy (B.A.L.E.), and the Governor's Institutes of Vermont. In addition to her legislative position, Sarah works for Building Bright Futures - a quasi-public nonprofit that supports and advances early childhood policy and service delivery.

Like the youth I work with at the Teen Center, that herstory of neglect and vulnerability is a bull's eye on their forehead. Poverty exploitation access trauma girls women "economic security". I'm curious, hopeful and excited to watch what grows out of this "unfinished agenda".

She is also Chairman of the Board of Trustees of the Massachusetts General Hospital, a Board Member of Partners Healthcare System and WGBH public broadcasting. Dean Minehan serves as Chair of the Boston Women's Workforce Council and Chairman of the Massachusetts Governor's Council of

Economic Advisors. Dean Minehan has received numerous awards and accolades throughout her career including an elected Fellow of the American Academy of Arts and Sciences in 2009, named the 2002 "New Englander of the Year" by the New England Council, and received the Lifetime Achievement Award from the Boston Chamber of Commerce in 2006. Minehan holds a B.A. from the University of Rochester, an M.B.A. from the Stern School at New York University, and a number of honorary degrees.

**Evelyn F. Murphy**

Former Lt. Governor of Massachusetts, Founding President of The Wage Project, Inc.  
The WAGE Project, Inc., Brookline, Massachusetts

Evelyn Murphy is President of The WAGE Project, Inc. (WAGE) a national, grassroots organization to eliminate the gender wage gap and author of *Getting Even: Why Women Don't Get Paid Like Men and What to Do About It.* WAGE has helped young women on 400 campuses in 49 states begin their careers paid fairly through highly interactive salary negotiation workshops. WAGE has also conducted salary negotiation workshops for working women at YWCAs; Mayor's and Governor's offices, and for women CPAs, lawyers, librarians, scientists, administrators, and executives. Evelyn Murphy earned a BA from Duke University in mathematics; a MA in economics from Columbia University; and a PhD in economics from Duke University. From 1975-1978, as Massachusetts Secretary of Environmental Affairs, she led the successful effort to block offshore oil drilling on the Georges Bank. As Secretary of Economic Affairs from 1983-1986, she initiated Centers of Excellence to advance biotechnology, marine sciences, photovoltaics, polymers and microelectronics. In 1986, Evelyn

Murphy was elected Lieutenant Governor on Massachusetts, becoming the first woman in the state's 200 year history to hold constitutional office. Prior to that, no woman had ever been elected Governor, Lieutenant Governor, Secretary of State, Attorney General, Treasurer, Auditor, or United States Senator in Massachusetts. She is a Director of The Commonwealth Institute; and on the Advisor Board of the CWPPP, UMass Boston. Dr. Murphy is the recipient of eleven honorary degrees, a distinguished graduate alumni award of Duke University, and over one hundred national, state, and community awards.

Kate Rushford Murray grew up in the Northeast Kingdom of Vermont and attended Sacred Heart High School in Newport, VT. She has written numerous articles and led frequent discussions in the fields of both music and religious art and has written the book, *Field Guide to the Saints*. She has served on a number of boards, including the Women's Fund of New Hampshire, the New Hampshire Charitable Foundation (Piscataqua Region), The Music Hall in Portsmouth, NH, and the Currier Museum of Art in Manchester, NH. She currently is on the Planning Board and the Historic District Commission for the town of New Castle and is on the board of the Portsmouth

Historical Society. She also writes a weekly column for the Portsmouth Herald.
